Agreement

This agreement is made between the indemnitor and the bondsman who is an agent for Seneca Insurance Company, Inc. In consideration of the bondsman bailing the above named defendant from jail, the indemnitor agrees:

1. That the bail bond fee is earned, in full, at the time the bail bond is written, and the indemnitor thereafter has no right to refund of any part of the bail bond fee. That if this defendant violates a condition of his bail bond, the bondsman may revoke the bail bond and does not have to refund any part of the bail bond fee to any person.
2. That the indemnitor will assure the defendant's appearance before the appropriate court, as such appearances are required during the time that this bail bond is in effect.
3. That the indemnitor will at all times indemnify and save the bondsman harmless from and against any and all claims, demands, liabilities, charges, recovery or bounty fees and costs, bail bond forfeiture, judgments and reasonable attorney's fees which the bondsman may incur by reason of the bail bond provided for this defendant.
4. That the indemnitor shall be responsible for the following fixed rate charges in regard to this defendant:
 - 1.) \$150 if a show cause is issued to the bondsman, even if due to court error.
 - 2.) \$45 per hour investigative fee.
 - 3.) \$35 if indemnitor's check is returned for any reason.
 - 4.) \$75 to substitute an indemnitor.
5. If the indemnitor wants to be relieved of liability hereunder by revoking this defendant's bail bond, indemnitor must, in advance, pay bondsman a recovery fee of at least \$250. This fee may be as high as 10% of the amount of the bail bond depending upon the difficulty in recovering and surrendering defendant.
6. That the indemnitor's obligations hereunder continue until such time as the bondsman is relieved of all duties, demands, liabilities, obligations, costs or expenses which may be or have been incurred as a result of this defendant's bail bond.
7. Indemnitor hereby waives his rights under all state and federal Privacy Acts and authorizes any private business or governmental agency, local, state or federal, to release to the bondsman or his agent any information it may have regarding indemnitor.
8. This agreement shall be construed and enforced under the laws of Virginia and Hampton, Virginia, shall be a proper venue in all cases. Invalidation of any part of this agreement shall only effect that part declared invalid. Indemnitor waives his homestead exemption as to any debt incurred pursuant to this agreement. Use of the plural herein shall include the singular and use of the singular the plural. Use of masculine gender shall include the feminine. A photo or duplicate copy of this agreement shall be treated as an original.

I understand and voluntarily enter into this agreement. This agreement is executed in two parts and at least one of the indemnitors has received a copy of this agreement.
